**THEME** – "Bohemian Rhapsody"- I can hear some of you saying "What is Bohemian?" Please take note of the following changes to the SACC Standard of Points (as per the Breed Council Secretary, following the AGM):

### General:

**1: All breed standards, current and in the future, should include, under Faults:**

- Any defects as listed in the Relevant to All Breeds Section.

**2: Change to the Faults section of all Breed Standards:**

- All breed standards, current and in the future, should show only breed specific faults, not those which apply to all breeds.

### Asian SOP:

The eye colour descriptions were changed (corrected) - refer to the updated SOP.

## INFO FOR BREEDERS

So you endorse your pedigrees "Not to be bred from"- how sure are you that your buyers are adhering to your endorsement?

Breeders have the right to decide whether a kitten should be bred from or not because they know their lines and are acting responsibly.

Years ago there was only one registering body in South Africa and therefore all pedigree endorsements were adhered to, so if a buyer tried to register a litter from a "not to bred from" cat or applied for a stud number for a "not to be bred from" cat- bells and whistles would sound and the litter would not be registered nor would a stud number be issued.

This is no longer the case because in South Africa at present there are 3 Cat Registering Bodies.

2 of the registries issue a stud number to working males after testicular verification by a Vet. This stud number becomes part of the cat's pedigree. 1 registry asks for the breeding females in the cattery to be listed.

1 registry permits Novice Registrations.

What is Novice Registration? It permits pedigreed unregistered kittens to be registered.

If you sell a "Not to be Bred from" female cat – and the new owner mates her (either intentionally or by mistake) - the kittens are generally sold as pedigreed but unregistered to someone else. This new owner visits a cat show and decides that he/she would like to enter the pedigree section of a cat show- so he/she applies for novice registration.

Therefore how do you as a breeder preserve and/or protect your lines, as well as maintaining trust in those you sell to.

The best way is to ENS (Early Neuter and Spay) your kittens prior to re-homing.

Many breeders and vets still oppose the practice of ENS, so if you are one of these breeders then perhaps you need to find another way of ensuring that your "not to be bred from" cats do not end up having registered kittens.

### **It is possible.**

Because, although our goals are very similar, each of the 3 registering bodies (SACC; CFSA & CASA/WCF) are unique and governed by their own separate Rules and Regulations.
